WHITNEY LAKES PROVINCIAL PARK

All those parcels or tracts of land, situate, lying and being in the fifty-sixth (56) township, in the fourth (4) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The south half of section fifteen (15), the south east quarter of section sixteen (16), all those portions of the north east quarter of section eight (8), the north half of section nine (9) and the south east quarter of section seventeen (17) lying generally to the north and east of the northeasterly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 5047 M.C. and are not covered by any of the waters of Whitney Lake, all that portion of section eleven (11) not covered by any of the waters of Ross Lake and an unnamed lake, all those portions of the north east quarter of the said section eleven (11) and the south east quarter of section fourteen (14) which comprise Island Number four (4) in Ross Lake, all that portion of the south west quarter of the said section fourteen (14) which lies to the south of the southerly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. R 4194 and is not covered by any of the waters of an unnamed lake, all those portions of the west half of the said section sixteen (16) and the north east quarter of the said section seventeen (17) which are not covered by any of the waters of Whitney Lake, all those portions of section twenty (20) and the south half and north west quarter of section twenty-nine (29) not covered by any of the waters of Borden Lake, all those portions of the north east and south west quarter of section twenty-one (21), the west half of section twenty-seven (27), section twenty-eight (28), legal subdivisions one (1), two (2), eight (8) and the south half of legal subdivision seven (7) of section thirty-two (32) and the south west quarter of section thirty-three (33) not covered by any of the waters of Laurier Lake, all those portions of the north west quarter of the said section twenty-one (21) and the north east quarter of the said section twenty-nine (29) not covered by any of the waters of Borden Lake and Laurier Lake, all that portion of the south east quarter of the said section thirty-three (33) not covered by any of the waters of Laurier Lake and Lake Number one (1) and all that portion of the west half of section thirty-four (34) of the said township, which lies to the south and west of the southwesterly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 3747 N.Y., containing one thousand four hundred ninety-three and one hundred sixteen thousandths (1,493.116) hectares (3,689.44 acres), more or less.

SAVING AND EXCEPTING:

- 1) One and three hundred thirty-one thousandths (1.331) hectares (3.29 acres), more or less, out of the north west quarter of the said section nine (9) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. R 4189.
- 2) One and four hundred thousandths (1.400) hectares (3.46 acres), more or less, out of the south east quarter of the said section fifteen (15) required for a surveyed roadway, as shown upon the said plan No. R 4194.
- 3) Three hundred fifty thousandths (0.350) of a hectare (0.86 of an acre), more or less, out of the said south east quarter of section fifteen (15) required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 842 2076.
- 4) Four thousandths (0.004) of a hectare (0.01 of an acre), more or less, out of the southwest quarter of the said section twenty (20) required for a surveyed roadway, as shown upon the said plan No. 5047 M.C.
- 5) One and two hundred forty-six thousandths (1.246) hectares (3.08 acres), more or less, out of the southwest quarter of the said section twenty-nine (29) required for road and extra road as shown upon a plan of survey of record in the said Land Titles Office as No. 832 2804.

The lands herein described contain one thousand four hundred eighty-eight and seven hundred eighty-six thousandths (1,488.786) hectares (3,678.74 acres), more or less.
