BIG KNIFE PROVINCIAL PARK

SCHEDULE "A"

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the fortieth (40) township, in the sixteenth (16) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) All those portions of the north half of section thirty-four (34) and the statutory road allowance adjoining the east boundary of the north east quarter of the said section thirty-four (34), which lie within the reservoir right-of-way, as shown upon a plan of survey of the said right-of-way of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 6116 H.W., and all those portions of the north half and south east quarter of section thirty-five (35) and the statutory road allowance adjoining the east boundary of the southeast quarter of the said section thirty-five (35) of the said township, which lie within the said reservoir right-of-way and to the south of the 2,194 foot contour line which represents the full supply level thereof, as shown upon the said plan No. 6116 H.W., containing fifty-three and three hundred twenty- thousandths (53.320) hectares (131.75 acres), more or less.
- (B) All that portion of the west half of section thirty-six (36) of the said township, which lies within the reservoir right-of-way as shown upon a plan of survey of record in the said Land Titles Office as No. 6049 H.W., to the south and east of the said 2,194 foot contour line and to the south and west of the westerly limits of two (2) surveyed roadways, as shown upon plans of survey of record in the said Land Titles Office as Nos. 2276 R.S. and 107 N.Y., containing three and nine hundred fifty-eight thousandths (3.958) hectares (9.78 acres), more or less.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the forty-first (41) township, in the sixteenth (16) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the south west quarter of section two (2) and the statutory road allowance adjoining the south boundary thereof, all those portions of the south half and north west quarter of section three (3) and the statutory road allowances adjoining the south boundary of the south half and the east boundary of the south east quarter of the said section three (3) and the east boundary of the east half of section four (4), and the intersection adjacent to the south east quarter of the said section three (3) of the said township, which lie within the said reservoir right of-way as shown upon the said plan No. 6116 H.W., and to the south of the said 2,194 foot contour line, containing fifty-one and three hundred sixty-five thousandths (51.365) hectares (126.92 acres), more or less.

The lands herein described contain one hundred eight and six hundred forty-two thousandths (108.642) hectares (268.45 acres), more or less.

SCHEDULE "B"

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the fortieth (40) township, in the sixteenth (16) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) All those portions of the north half of section thirty-four (34) and the north half of section thirty-five (35) of the said township, which lie generally to the south of the southerly boundary of the reservoir right-of-way, as shown upon a plan of survey of the said right-of-way of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 6116 H.W., containing one hundred fifty-one and two hundred sixty-one thousandths (151.261) hectares (373.76 acres), more or less.
- (B) All that portion of the south east quarter of section thirty-five (35), which lies to the south of the southerly boundary of the said reservoir right-of-way, as shown upon the said plan No. 6116 H.W., and generally to the north of the northeasterly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 1297 N.Y., containing four and one hundred sixty thousandths (4.160) hectares (10.29 acres), more or less.
- (C) All that portion of the south east quarter of section thirty-five (35) of the said township, covering an access roadway, as shown upon the said plan No. 1297 N.Y., containing one and eight hundred nine thousandths (1.809) hectares (4.47 acres), more or less.
- (D) All that portion of the south west quarter of section thirty-six (36) of the said township, which lies to the south of the southerly boundary of the reservoir right-of-way, as shown upon a plan of survey of record in the said Land Titles Office as No. 6049 H.W., to the west of the westerly limit of a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 107 N.Y., and to the north of a line drawn easterly and perpendicular to the east boundary of section thirty-five (35) of the said township through a point on the said east boundary of section thirty-five (35), which point is distant three hundred thirty (330.00) feet south from an iron post marking the intersection of the southerly boundary of the said reservoir of right-of-way with the east boundary of the south east quarter of the said section thirty-five (35), as shown upon the said plan of survey of record in the said Land Titles Office as No. 6116 H.W., containing eight hundred twenty-six thousandths (0.826) of a hectare (2.04 acres), more or less.

SECONDLY:

All that parcel or tract of land, situate, lying and being in the forty-first (41) township, in the sixteenth (16) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

All that portion of the south west quarter of section three (3) of the said township, which lies generally to the south of the southwesterly boundary of the said reservoir right-of-way, as shown upon the said plan No. 6116 H.W., containing twenty-eight and three hundred sixty-five thousandths (28.365) hectares (70.09 acres), more or less.

The lands herein described contain one hundred eighty-six and four hundred twenty-five thousandths (186.425) hectares (460.65 acres), more or less.
