MOONSHINE LAKE PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying, and being in the seventy-ninth (79) township, in the eighth (8) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

- A) The north west quarter of section twenty-two (22), the north half and south east quarter of section twenty-eight (28), the north halves of sections twenty-nine (29) and thirty (30) and sections thirty-one (31) and thirty-two (32) of the said township, containing one thousand thirty-six and eight hundred forty-one thousandths (1,036.841) hectares (2,562.00 acres), more or less.

SAVING AND EXCEPTING:

- (1) One and eight hundred ninety thousandths (1,890) hectares (4.67 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 932 2537.
- (2) Six hundred and fifty-six thousandths (0.656) of a hectare (1.62 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 3610 P.X.
- B) The statutory road allowances adjoining the west boundaries of the north west quarter of the said section twenty-nine (29) and the west half of the said section thirty-two (32) of the said township, containing four and eight hundred forty-eight thousandths (4.848) hectares (11.98 acres), more or less.

SECONDLY:

All that parcel or tract of land, situate, lying and being in the seventy-ninth (79) township, in the ninth (9) range, west of the sixth (6) meridian, in the Province of Alberta, Canada, and being composed of:

The north east quarter of section twenty-five (25) of the said township, containing sixty-four and three hundred forty-seven thousandths (64.347) hectares (159.00 acres), more or less.

The lands herein described contain one thousand one hundred three and four hundred ninety-one thousandths (1,103.491) hectares (2,726.69 acres), more or less.
