

GREENE VALLEY PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the eighty-first (81) township, in the twenty-first (21) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The north east quarter of section thirty-four (34) and the west half of section thirty-five (35) of the said township.

SAVING AND EXCEPTING:

All those portions of the described lands required for a railway right-of-way, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 5543 B.A.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the eighty-second (82) township, in the twenty-first (21) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south west quarter of section three (3), the north half and south east quarter of section four (4), section eight (8), the west half of section nine (9), the south half and north west guarter of section seventeen (17), the west half of section twenty (20), the north west quarter of section twenty-nine (29), the east half of section thirty-one (31), the west half and legal subdivisions two (2) and seven (7) of section thirty-two (32), legal subdivisions eleven (11) and twelve (12), the south half, north west guarter and the south half and north west guarter of the north east guarter of legal subdivision thirteen (13) and the south half and the south half of the north half of legal subdivision fourteen (14) of the said section three (3), the north east quarter, the north half of the north west quarter and the north east quarter of the south east quarter of legal subdivision nine (9), the north half, the north east quarter of the south west quarter and the north half and the south east quarter of the south east quarter of legal subdivision fifteen (15) and legal subdivision sixteen (16) of section five (5), legal subdivision nine (9), the east half of the north east quarter of legal subdivision ten (10), the east half and the east half of the north west guarter of legal subdivision fifteen (15) and legal subdivision sixteen (16) of section seven (7), legal subdivisions one (1) and two (2), the east half and the east half of the west half of legal subdivision seven (7), legal subdivisions eight (8) and nine (9), the south east guarter, the south half and north east quarter of the north east quarter and the south east quarter of the south west quarter of legal subdivision ten (10), the south east quarter of the south east quarter of legal subdivision fifteen (15) and the east half and the south half and the north east quarter of the south west quarter of legal subdivision sixteen (16) of section eighteen (18) and the west half of legal subdivision three (3) and legal subdivisions four (4), five (5) and six (6) of the said section twenty-nine (29) of the said township.

SAVING AND EXCEPTING:

- (1) One and nine hundred seventy-eight thousandths (1.978) hectares (4.89 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey or record in the said Land Titles Office as No. 4071 E.O.
- (2) Eight hundred fifty-five thousandths (0.855) of a hectare (2.11 acres), more or less, out of the south east quarter of the said section thirty-two (32), as shown upon a descriptive plan of record in the said Land Titles Office as No. 922 2932.
- (3) All those portions of the described lands required for a railway right-of-way, as shown upon the said plan No. 5543 B.A.

THIRDLY:

All those parcels or tracts of land situate, lying and being in the eighty-third (83) township, in the twenty-first (21) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

- (A) The north half and south west quarter of section four (4), the east half of section nine (9), the west half of section fifteen (15), the east half of section sixteen (16), section twenty-one (21), the south half and north west quarter of section twenty-two (22), the west half and the south half of the south east quarter of legal subdivision one (1), legal subdivisions two (2) and seven (7) and the west half, the west half of the north east quarter and the north west quarter of the south east quarter of legal subdivision eight (8) of the said section four (4), legal subdivisions three (3) and four (4), the south east quarter of the south east quarter of legal subdivision five (5) and legal subdivision six (6) of the said section nine (9), the north west quarter and the north east quarter of the south west quarter of legal subdivision one (1), the north east quarter of the north west quarter of legal subdivision two (2), the east half, the north half and south west quarter of the north west quarter and the south east quarter of the south west quarter of legal subdivision seven (7), the north half and south east quarter of the north east quarter, the north half and south west quarter of the north west quarter and the south half and north west quarter of the south west quarter of legal subdivision eight (8), legal subdivisions nine (9) and ten (10), the west half of the south west quarter and the south west quarter of the north west quarter of legal subdivision eleven (11), legal subdivision twelve (12), the west half, the west half of the north east quarter and the south half and north west quarter of the south east quarter of legal subdivision thirteen (13), the north west quarter and the east half of the south east quarter of legal subdivision fourteen (14), legal subdivision fifteen (15) and the west half, the west half of the south east quarter and the south west quarter of the north east quarter of legal subdivision sixteen (16) of section ten (10), all that portion of the south west guarter of section twenty-eight (28) lying generally to the south and west of the right bank of the Heart River and all that portion of the east half of section twenty-nine (29) of the said township lying generally to the east of the easterly limit of Highway No. 744, to the east of the easterly boundaries of Lots eleven (11) and twelve (12) of the Peace River Landing Settlement and to the south and west of the right bank of the said Heart River.
- (B) All that portion of the south east quarter of section thirty-two (32) of the said township being more particularly described as follows: commencing at a point on the south boundary of the said south east quarter distant two hundred nineteen and six hundred fifty-four thousandths (219.654) metres (720.65 feet) westerly from the south east corner thereof; thence northerly and at right angles to the said south boundary distant one hundred forty and eight hundred seventeen thousandths (140.817) metres (462.00 feet); thence westerly and parallel to the said south boundary distant sixty and three hundred fifty thousandths (60.350) metres (198.00 feet); thence southerly at right angles to the said south boundary to a point thereon; thence easterly along the said south boundary to the point of commencement.

SAVING AND EXCEPTING:

All those portions of the described lands required for a railway right-of-way, as shown upon the said No. 5543 B.A.

The lands herein described contain three thousand one hundred thirty-one and three hundred ten thousandths (3,131.310) hectares (7,737.36 acres), more or less.
