ELBOW-SHEEP WILDLAND PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the partially surveyed seventeenth (17) township, in the sixth (6) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

Section thirty-three (33) and all those portions of the north half and south west quarter of section twenty-seven (27), section twenty-eight (28), the north east quarter of section twenty-nine (29), sections thirty-two (32), thirty-four (34), thirty-five (35) and the north half and south west quarter of section thirty-six (36) of the said township, as shown outlined upon a map or plan of record in the Department of Environmental Protection at Edmonton as No. P0345 GEN., containing one thousand one hundred thirty-six and nine hundred thirty-four thousandths (1,136.934) hectares (2,809.33 acres), more or less.

SECONDLY:
