BEEHIVE NATURAL AREA

FIRSTLY

All those parcels or tracts of land, situate, lying and being in the partially surveyed 12th township, in the 5th range, west of the 5th meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of what would be if surveyed under the present system of Alberta Land Surveys.

- The north half of section 16
- The north east quarter of section 17
- The south half and north east quarter of section 20
- Sections 21 and 28
- The east half of section 29
- Sections 32 and 33
- The north west quarter of section 34
- Legal subdivisions 5, 6, 15 and 16 of section 34
- Legal subdivision 13 of section 35

All those portions of the north west quarter of section 17, the north east quarter of section 18, the east half of section 19, the north west quarter of section 20, the west half of section 29, the north east quarter of section 30 and the north half and south east quarter of section 31, which lie generally to the east of the Alberta-British Columbia Boundary.

All that portion of legal subdivision 14 of section 35, which lies to the west of the right bank of the Oldman River.

SECONDLY

All those parcels or tracts of land, situate, lying and being in the partially surveyed 13th township, in the 5th range, west of the 5th meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of what would be if surveyed under the present system of Alberta Land Surveys.

- Sections 3, 4 and 5
- The north half of section 7
- Sections 8 and 9
- The south west quarter of section 10
- Sections 16 to 20 inclusive
- The west half of section 21
- The south half of section 30

All that portion of the south half and north east quarter of section 6, which lies generally to the east of the Alberta-British Columbia Boundary.

All that portion of the south half of section 7, which lies generally to the north and east of the Alberta-British Columbia Boundary.

All those portions of the west half of section 2, the north half and south east quarter of section 10, the west half of section 15, the east half of section 21 and the south west quarter of section 22, which lie generally to the south and west of the right bank of the said Oldman River.

All those portions of the south half of section 28, the south half and north west quarter of section 29 and the north half of section 30, which lie generally to the south of the right bank of the said Oldman River.

THIRDLY

All those parcels or tracts of land, situate, lying and being in the unsurveyed 13th township, in the 6th range, west of the 5th meridian, in the Province of Alberta, Canada, and being composed of:

All those portions of what would be if surveyed under the present system of Alberta Land Surveys.

The north half and south east quarter of section 24
The south east quarter of section 25

All those portions of the east half of section 12, section 13, the north half and south east quarter of section 23, the south west quarter of section 24 and the south west quarter of section 26, which lie generally to the east of the Alberta-British Columbia Boundary.

All that portion of the north east quarter of section 25, which lies generally to the south of the right banks of the said Oldman River and its tributary therein.

All those portions of the west half of section 25 and the north half and south east quarter of section 26, which lie generally to the south of the right bank of the said tributary.
